ANNUAL GENERAL MEETING – Greetings to 2024/2025!

The Murwillumbah Historical Society's Annual General Meeting was held on Monday, 15 April 2024 at the Tweed Regional Museum at 1:00 pm. Annual General Meetings are Janus-like events, a last glance cast back before welcoming the promise of the coming year. 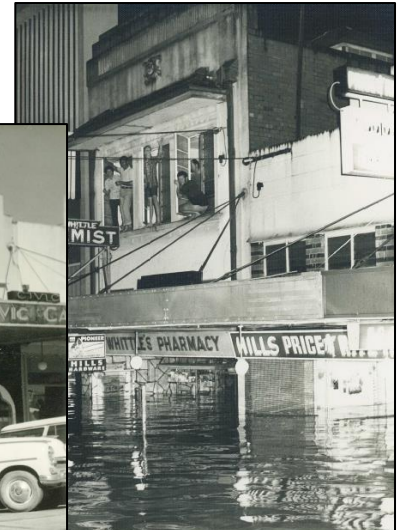

History in a Box

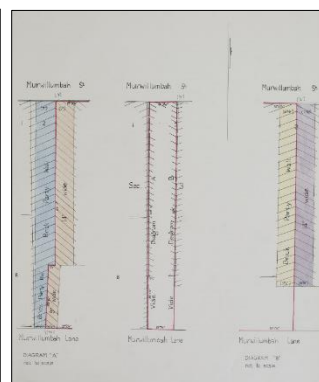
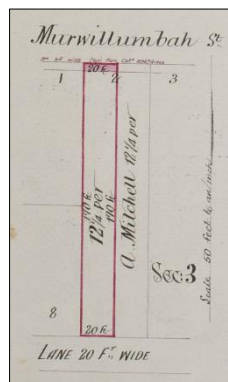
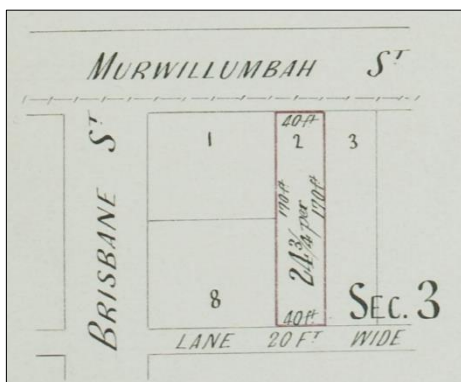
110 Murwillumbah Street

The Society is more than happy to undertake research about local properties. A recent example is a request to provide any photos held in the Tweed Regional Museum's collection of 110 Murwillumbah Street. Locals will recognise this property as having been in its time the location of Hills Hardware and the Civic Café. Sadly, there are fewer photos of these shops than one would expect. Nevertheless, the enquiry also gives the researcher the opportunity to look for information in other places.

New South Wales Land Services still identifies the property as Hills Hardware Pty Limited. Its title is numbered Lot 1 of Deposited Plan 335913. The prior title reference is Volume 10627 Folio 93. This allows identification of owners of the property all the way back to the subdivision of the Colonial Sugar Refining holding of Murwillumbah South in the late 1880s. Patrick Glynn, a 'laborer', was the first owner of the property in 1894. He subdivided it, selling one part to Agnes Mitchell, and the other, the one of interest, to Kate Spies, wife of the plumber William Wenzel Spies, in 1900. It 1905 it was transferred to Annie Sarah Kelly, wife of Frederick Augustus Kelly, a baker. In 1914 she transferred it to her husband, now an insurance agent in Lismore. In 1921/1925 it was transferred to Richard Sweetnam, farmer; in 1929 to George Donald Gregor, master baker; and in 1936 to the John Charles McIntoshes (senior and junior, the latter a solicitor of Lismore). New certificates of title were issued in 1940 and 1941. In 1957/1958 the proprietors became Peter Stathis and Mark Cassimatis, refreshment room proprietors. This is the last dealing in the public record. Subsequent dealings are not in the public domain.
